International human rights law is often criticized as an infringement of constitutional democracy. Mayerfeld shows that the embrace of international human rights law has inhibited human rights violations in Europe whereas its marginalization has facilitated human rights violations in the United States. A longstanding policy of "American exceptionalism" was a major contributing factor to the Bush administration's use of torture after 9/11. Mounting a combination of theoretical and empirical arguments, Mayerfeld concludes that countries genuinely committed

to constitutional democracy should incorporate international human rights law into their domestic legal system and accept international oversight of their human rights practices.
