

Seventh Day Adventist Church Heritage Manual

This book is a story of how Adventists came to view themselves as a prophetic people, of their growing awareness of a responsibility to take their unique message to all the world, and of their organizational and institutional development as they sought to fulfill their prophetic mission. By the end of this volume, you as a reader and I as a author will find ourselves in the flow of Adventist history. - Millerite Roots. Era of Doctrinal Development. Era of Organizational Development. This work gives a detailed history and defense of the Advent Movement of the 1840's known as Millerism, the movement from which the Seventh-day Adventist denomination sprang. The book is based on original sources, William Miller's correspondence, contemporaneous books, pamphlets, journals, newspapers. The first half is devoted to the history of the movement, and the second half to an examination of charges made against the Advent believers, such as that they wore ascension robes, that the Millerite preaching filled the asylums, and so forth.

This second edition covers its history through a chronology, introductory essay, appendixes, and an extensive bibliography. The dictionary includes over 600 cross-referenced entries on key people, cinema, politics and government, sports, and critics. This book is ideal for students, researchers, and general readers.

Tanzanian Adventism exemplifies one of the most fascinating shifts in the history of religions: the growth of Christianity in Africa. Most striking in this account is the analysis of a minority denomination's transformation to a veritable "folk church."
